MARKET SUPPLEMENT PROGRAM

Report of the Market Supplement Review Committee

Respiratory Therapist

OBJECTIVE

The objective of the Saskatchewan Market Supplement Program is to ensure that Saskatchewan health care employers can attract and retain the employees required to provide appropriate health care services to the people of Saskatchewan.

This program is designed to address specific skill shortages by use of a temporary market supplement to attract and/or retain qualified employees. The program is designed to ensure that temporary market supplements respond to valid labour market criteria to address recruitment and/or retention pressures.

OVERVIEW

The Market Supplement Review Committee (MSRC) reviewed updated documentation submitted in the annual review process regarding the market supplement for the Respiratory Therapist classification. The initial market supplement report was released by the Market Supplement Review Committee August 6, 2002 and implemented on October 16, 2002. The Respiratory Therapist classification has had annual reviews in 2003, 2004, 2005, 2006 and now. A market supplement was implemented in May 2008 due to the market supplement adjudication process. This latest report is to be considered as part of the on-going review of the market supplement process for this classification.

There were six health regions that reported to this review on Respiratory Therapists. Respiratory Therapists are members of the <u>Health Sciences Association of Saskatchewan</u> (HSAS).

Role of a Respiratory Therapist:

Respiratory Therapists are an essential part of the health care team providing such services as cardiopulmonary resuscitation ventilator management, oxygen and aerosol therapy, patient assessment and evaluation, and diagnostic services including pulmonary function testing and blood analysis.

Qualifications:

Respiratory Therapists must be a graduate of a Respiratory Therapy training program approved by the <u>Canadian Society of Respiratory Therapists</u> (C.S.R.T.) and, successful completion of an exam approved by the Canadian Society of Respiratory Therapists. Membership in the C.S.R.T. and the <u>Saskatchewan Association of Respiratory Therapists</u> (S.A.R.T.) is mandatory.

In Canada there are 18 accredited respiratory therapist schools that train respiratory therapists. In western Canada, there are four schools as follows: Northern Alberta Institute of Technology, Southern Alberta Institute of Technology, Thomson Rivers University (formerly University College of the Cariboo), and the University of Manitoba – School of Medical Rehabilitation. Respiratory Therapists may require up to six months of orientation and training.

Saskatchewan Health provides bursary assistance to Saskatchewan respiratory therapist students.

Information regarding budgeted positions and vacancies is provided in the following table:

ANALYSIS

The MSRC discussed the Labour Market Criteria as required by the Market Supplement Program framework.

SERVICE DELIVERY IMPACTS: (Employers were asked to provide information that addresses current service delivery impacts resulting from staff shortages, potential staff short term service delivery impacts, potential long term service delivery impacts and options for alternative service delivery models).

There were six health regions that reported to the market supplement survey.

Of the six regions, four report no service delivery issues and two report minor issues related to recruitment and retention such as increased overtime. A lack of budgeted positions was also reported as an issue by some regions.

VACANCY RATE ANALYSIS: (Employers were requested to provide information about the frequency and timing of vacancy occurrences {i.e., seasonal vacancies; do the vacancies always follow an event; etc.} and to identify trends that may affect recruitment/retention efforts).

Health regions have reported a total of five full time vacancies in the province. The Saskatoon Health Region is currently recruiting to their vacancies.

TURNOVER RATES: (Employers were asked to provide local analysis of reasons for leaving and trends that may be emerging. They were also asked to provide annual turnover {loss of employees to other competitor employers} ratio to the existing staff complement {budgeted positions} in the given occupation.).

Of the regions that report and track turnover, the following data is reported:

- 2009 (year to date) -6
- 2008 6
- 2007 7

Employers have identified several reasons for turnover including: retirements, spousal transfer, wage rates, lack of full time employment hours, and others. Discrepancies in turnover data from previous reports may be as a result of a different number of employers reporting year to year.

RECRUITMENT ISSUE ANALYSIS: (Employers were asked to provide information such as length of recruitment times, training investments, licensing issues, supply and demand issues, etc., as well as information that would identify trends that may affect recruitment and/or retention efforts).

Of the regions that reported vacancies in the past, the following recruitment and retention initiatives were utilized:

- Offering higher initial pay rates,
- Increasing the number of FTE's,
- Attending career fairs,
- Relocation allowance,
- Recruitment allowance,
- Training allowances,
- Implementing student practicum's,
- Changing job responsibilities and,
- Advertising.

Overall, health regions report a moderate amount of recruitment effort as compared to previous years.

As reported in previous market supplement reports, Regina Qu'Appelle and Saskatoon Health Region continue to work with Ministry of Health and Alberta Learning in the delivery of a

Respiratory Therapist training program. The program purchases seats at the Southern Alberta Institute of Technology in Calgary for Saskatchewan residents and allows them to perform their clinical training in Saskatchewan. The program sponsors eight Respiratory Therapists per year for the province. In the past this program has successfully recruited students to Saskatchewan health regions.

SALARY MARKET CONDITIONS: (Employers were asked to identify situations where their salary levels are lower than other employers that they would expect to recruit employees from or other employers that recruit their employees. This may be local, provincial, regional, national or international depending on the occupation group and traditional recruitment relationships. Cost of living considerations may or may not be appropriate to factor into market salary comparisons).

The MSRC reports the following market conditions for Respiratory Therapists (Diploma):

- Saskatchewan health regions Minimum \$26.946/hour, maximum \$32.856/hour, 5 steps. Effective April 1, 2008.
- Alberta health regions Minimum \$30.900/hour, maximum \$39.710/hour, 9 steps. Effective April 1, 2009.
- British Columbia health regions Minimum \$26.170/hour, maximum \$32.670/hour, 6 steps. Effective April 1, 2009.
- Manitoba health regions Minimum \$27.000/hour, maximum \$32.237/hour, 7 steps. Effective April 1, 2009.

The SAHO/HSAS collective agreement expired March 31, 2009.

CONCLUSIONS & RECOMMENDATIONS:

Considering the labour market criteria under the provincial framework, the Market Supplement Review Committee makes the following conclusions:

- Health regions report minor service delivery issues related to recruitment and retention.
- Health regions report five vacancies out of 94 full time positions.
- One health region is attempting to recruit to vacancies at the time of this report.

Having reviewed the information as provided by employers and considering the labour market criteria, the Market Supplement Review Committee recommends maintaining the current market supplement for the Respiratory Therapist classification.
